

This ECMWF Contributor Agreement ("ECA") applies to any contribution that you, the person identified below ("you") make to any product or project (a "Project") managed by us, The European Centre for Medium-Range Weather Forecasts ("ECMWF") and sets out the rights you grant to ECMWF in the contributed materials. In order to clarify the intellectual property licence granted with contributions from any person or entity, ECMWF must have this ECA on file signed by you, indicating your agreement to the licence terms below. This ECA is for your protection as a contributor as well as the protection of ECMWF and its licensees; it does not change your rights to use your own contributions for any other purpose. If you agree to be bound by this ECA, fill in the information and sign the ECA where requested below. Please read this ECA carefully before signing.

1. The term 'Contribution' or 'contributed materials' means any source code, object code, patch, tool, sample, graphic, specification, manual, documentation, original work of authorship, including any modifications or additions to an existing work, that is submitted by you to ECMWF for inclusion in a Project or any other material posted or submitted by you to a Project. For the purposes of this definition, "submitted" means any form of electronic, verbal, or written communication sent to ECMWF, including but not limited to communication on electronic mailing lists, source code control systems, and issue tracking systems that are managed by ECMWF for the purpose of discussing and improving a Project. ECMWF is entitled to treat as a contribution the contents of any communication from you other than one that is conspicuously marked, or otherwise no later than the time of communication designated in writing, by you as "Not a Contribution".
2. You hereby grant to ECMWF and to recipients of software distributed by ECMWF a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable, unrestricted licence under copyright and any other rights you have to exercise all such rights including, but not limited to, the right to reproduce, prepare derivative projects of, publicly display, publicly perform, and distribute your present and future Contributions and such derivative projects. This includes, at our option, the right to sublicense these same rights to third parties through one or more levels of sublicensees or other licensing arrangements. ECMWF shall be entitled but not required to incorporate your Contribution in a Project.
3. With respect to any patents you own, or that you can license without payment to any third party, you hereby grant to ECMWF a perpetual, irrevocable (except as stated below), non-exclusive, worldwide, no-charge, royalty-free license to:
  - make, have made, use, sell, offer to sell, import, and otherwise transfer your Contribution in whole or in part, alone or in combination with or included in any product, project or materials arising out of a Project to which your Contribution was submitted, and
  - at our option, to sublicense these same rights to third parties through one or more levels of sublicensees or other licensing arrangements. If any entity institutes patent litigation against you or any other entity (including a cross-claim or counterclaim in a lawsuit) alleging that your Contribution, or a Project to which you have contributed, constitutes direct or contributory patent infringement, then any patent licences granted to that entity under these terms for that Contribution or Project shall terminate as of the date such litigation is filed.
4. Except for the licences granted herein, you reserve all right, title and interest in and to your Contributions.
5. You are not obliged to provide support for your Contributions, except to the extent you desire to do so. You may provide support for free, for a fee, or not at all. Except as provided elsewhere in this ECA, you provide Contributions on an "as is" basis, without warranties or conditions of any kind, either express or implied, including, without limitation, any warranties or conditions of title, non-infringement, merchantability, or fitness for a particular purpose.
6. You covenant, represent, warrant and agree that:
  - each Contribution that you submit is and shall be an original project of authorship and has not been copied wholly or partly from any other source;
  - you are entitled legally to grant the rights set out in this ECA;
  - to the best of your knowledge, each Contribution will not violate any third party's copyrights, trademarks, patents, or other intellectual property or other rights;

- You have not assigned or agreed to assign any of your rights in any Contribution to any third party in any part of the world and that your Contribution submissions include complete details of any third-party license or other restriction (including, but not limited to, related patents and trademarks) of which you are aware and which are associated with any part of your Contributions;
  - if you are an individual and your employer or the person engaging you ("hirer") has any right to any intellectual property rights that you create that include any Contribution, you have received permission to make that Contribution on behalf of your employer or hirer, that your employer or hirer has waived such rights in the Contribution to the extent of the grant of rights in this ECA to ECMWF, or that your employer or hirer has executed a separate contributor licence agreement with ECMWF.
7. If you wish to submit work that is not your original creation, you may submit it to ECMWF separately from any Contribution, identifying the complete details of its source and of any license or other restriction (including, but not limited to, related patents, trademarks, and license agreements) of which you are aware, and conspicuously marking the work as "Submitted on behalf of a third-party: [named here]".
  8. You shall promptly notify ECMWF of any facts or circumstances of which you become aware that would make any of your warranties and representations in this ECA inaccurate in any respect.
  9. ECMWF may publicly disclose your participation in a Project, including the fact that you have signed the ECA.
  10. If there is a dispute arising in connection with this ECA we shall attempt to settle our differences in an amicable manner. If a dispute cannot be so settled, it shall be finally settled under the Rules of Conciliation and Arbitration of the International Chamber of Commerce by three arbitrators appointed in accordance with the said rules; the arbitrators shall sit in London England and English law shall apply. In accordance with Sections 45 and 69 of the Arbitration Act 1996, the right of appeal by either you or ECMWF to the High Court on a question of law arising in the course of any arbitral proceedings or out of an award made in any arbitral proceedings is hereby agreed to be excluded.
